

Regional Advance Mitigation Needs Assessment:

District 5 (Central Coastal, Monterey Bay, Pajaro, Salinas, San Francisco Coastal South Sub-basins):

- Coordination with regional and local transportation agencies
- Draft RAMNA release and public meeting January 20, 2020

District 1 (Mad-Redwood, Lower Eel, South Fork Eel Sub-basins):

- Coordination with regional and local transportation agencies
- Preparation of RAMNA undergoing internal review

District 11 (San Diego Sub-basins):

- Coordination with regional and local transportation agencies
- Initiation of RAMNA



Planning Process

Program Implementation:

- Advance Mitigation Program Final Formal Guidelines published: October 2019
- Statewide Advance Mitigation Initiative (SAMI) MOU amended to add the California Coastal Commission as a signatory: December 2019
- Advance Mitigation Program Master Process Agreement between Caltrans and the SAMI signatories finalized and signed: January 2020
- Significant progress on the internal procedures for developing mitigation project nomination, scoping, and programming procedures and documents
- Publicly posted the Statewide Advance Mitigation Needs Assessment Report for the second quarter 2017-2018
 fiscal year and held an educational public webcast with questions and answer session

Activity in the Advance Mitigation Account:


- Third of the four \$30 million annual deposits made
- Total funds in the account as of 6/30/2020: \$92,407,750
 - As of 12/31/2020 the value is \$92,579.085.15





Advance Mitigation Integration with Mitigation Tools and Alignment with Various Requirements:

- Improve tools and options to align agency requirements in implementing advance mitigation.
- Update mitigation bank policies and practices to accommodate advance mitigation purchases.
- Establish programmatic solutions with planned advance mitigation investments.
