Subject: SCOPE CHANGE AND SECOND ALLOCATION FOR A LOCALLY-ADMINISTERED STIP RAIL PROJECT, IN ACCORDANCE WITH GOVERNMENT CODE SECTION 14533 RESOLUTION MFP-20-02

ISSUE:

Should the California Transportation Commission (Commission) approve a second allocation for \$10,500,000 for construction and update the scope for the locally administered State Transportation Improvement Project (STIP) Rail Del Mar Bluffs Stabilization Project 4 project, in San Diego County (PPNO 75-2108)?

RECOMMENDATION:

The California Department of Transportation (Department) recommends that the Commission approve a second allocation for \$10,500,000 for construction and update the scope for the locally administered STIP Rail Del Mar Bluffs Stabilization Project 4 project, in San Diego County (PPNO 75-2108).

BACKGROUND:

The project received a construction allocation of \$2 million at the March 2019 Commission meeting. On February 28, 2021, a slide occurred within the project limits that requires emergency repairs. Because this emergency work was not part of the original allocation, it is necessary to add the scope of work and the funding necessary to address the emergency work.

Government Code Section 14533(a) authorizes the Commission to allocate funding in response to an emergency condition which has placed either people or property in jeopardy or which has caused or threatens to cause closure of a critical transportation facility or access to it.
