### <u>ISSUE:</u>

Should the California Transportation Commission (Commission) approve a Post-Fact time extension, to complete construction for the multi-funded State-Administered Proposition 1B-State Highway Operation and Protection Program (Prop 1B SHOPP), Proposition 1B-Trade Corridors Improvement Fund (Prop 1B-TCIF)/Border Infrastructure Program (BIP) project (PPNO 1035 and 0999D), in San Diego County, for the time period as described in the attachment?

#### **RECOMMENDATION:**

The California Department of Transportation (Department) recommends that the Commission approve a Post-Fact time extension, to complete construction for multi-funded State-Administered Prob 1B SHOPP/TCIF/BIP project (PPNO 1035 and 0999D), in San Diego County, for the time period as described in the attachment.

#### **BACKGROUND:**

In 2017 and 2018, the Commission allocated \$57,572,000 in construction capital and support for the multi-funded SHOPP/TCIF/BIP project, which was combined at construction. In accordance with the SHOPP and STIP Guidelines, the deadline to complete the Construction Contract Acceptance (CCA) for projects awarded in May 2019, is May 31, 2022. However, the Department did not meet this deadline, and is now requesting a Post Fact time extension for this phase.

These projects are coming to the Commission as Post-Fact time extension requests because they were not identified by one of the Department's project delivery reporting tools. The tool was developed primarily to track and report SHOPP project time extensions; however, it was discovered that the report was not capturing the entire population of projects, due to the way data was being filtered. This filtering resulted in missed/unidentified projects that needed time extensions across all programs (SHOPP and Non-SHOPP), as the reporting and tracking tool did not capture and alert all exceptions related to time extensions and timely use of funds requirements, due to various program nuances. As a result, the Department missed the submittal deadlines past the Timely Use of Funds (TUF) deadlines because the tool did not flag these types of projects.

The Department created the current list before the Commission by performing a detailed review through a manual analysis of each record which involved investigation all phases of the project in conjunction with the TUF requirements. The Department has made several enhancements and updates to the filtering of the tracking tool to make tracking and monitoring project related TUF information more accessible. The Department recognizes the need for better communication and education of the TUF requirements throughout the Department and making it part of the regular monitoring and oversight of the project delivery process.

The Department looks forward to the continued partnership with Commission staff and further discussions toward streamlining how the Department can improve its performance by meeting the TUF requirements.

This project was combined for construction with TCIF Route 11 - Enrico Fermi Drive to Otay Mesa East Port of Entry EA 11-05636 under EA 11-2888U.

During construction, the project encountered unexpected additional work, due to needing to building a retaining wall necessary for the placement of a fiber optic line. This delayed the initially planned specific scope of slope paving. This delay in construction also pushed out the project's one-year Plant Establishment Period (PEP) identified in the design phase. As a result, the PEP did not begin until February 1, 2022, and the Department missed the opportunity to request additional time required to complete the PEP at the time of allocation, and overlooked requesting a time extension before the CCA deadline.

Therefore, the Department is requesting a 9-month Post-Fact time extension for project completion to allow sufficient time to complete the PEP and finalize the CCA from May 31, 2022 to February 28, 2023.

As a result, the PEP did not begin until February 1, 2022, and the Department missed the opportunity to request additional time required to complete the PEP at the time of allocation, and overlooked requesting a time extension before the CCA deadline.
