Honorable Commissioners:

Trees and Trails is a coalition of local citizens and non-profit groups in Santa Barbara County that was formed to support the completion of the Modoc Multi-use Path project. The coalition



includes shareholders of the La Cumbre Mutual Water Company (landowner), users of region's cherished multi-use path system and many groups which advocate for sustainable transportation, the mobility challenged, seniors and school children as well as for environmental justice and climate sustainability. (See attached letter for complete list of project supporters).

Trees and Trails wants to convey its full support for staff's recommendations for the March 22-23 commission meeting and requests that the commission approve the Modoc Multi-use Path project for future funding and allocation of ATP funds for the project design and right-of-way phase.

There are many benefits for the path project including access, connectivity, safety, inclusivity and encouraging active transportation. Support for this project is extensive in the community. The Santa Barbara County Board of Supervisors voted unanimously to approve the MND on November 1, 2022. The County is now ready to complete final design and right-or-way acquisition and needs an allocation of funds for this work.

The project will close a 3/4-mile gap in a 20+ mile multi-use path network. The project will also provide controlled public access to increasingly rare urban open space for users of all ages and abilities consistent with the provisions of the Conservation Easement that was overwhelmingly approved by shareholders in 1999.

Trees and Trails appreciates the Commission's partnership with our regional and local agencies in closing gaps and extending our urban multi-use path network and making safe, active transportation a viable option for so many in the community.

RE: November 1, Agenda item #6: Consider recommendations regarding the Modoc Road Multi-Use Trail Phase II - SUPPORT

Dear Santa Barbara County Board of Supervisors,

We the undersigned organizations, representing thousands of residents of Santa Barbara County, thank you for working to improve pedestrian and bicyclist safety through your Active Transportation planning and for securing grant funding for the Modoc Path connecting the City of Santa Barbara's path near Calle De Los Amigos to the widely used Obern Trail at Encore Drive. We urge you to approve the revised MND and complete this project to close the gap in our Coastal Route. The benefits are many:

- **Connectivity:** This new path will provide safe, enjoyable, access for all. It will enable the young and old, residents and visitors, able and less able-bodied to access the beach, the Mesa, schools, shopping, jobs and most importantly, the outdoors. The Modoc Path will create a vital link between two existing multi-use paths, creating a more complete network of safe, off-street facilities spanning from Carpinteria to Goleta. It will connect the Las Positas-Modoc, Obern and Maria Ygnacio multi-use path systems, providing a continuous connection between homes, jobs, schools and open spaces. The Modoc Path gap closure will result in 14.5 miles of linked multi-use paths.
- **Safety:** The Modoc Path will replace unsafe on-road facilities and allow people of all ages and abilities to travel with ease by foot, by bicycle or wheelchair. This section of Modoc Road has discontinuous sidewalks, inadequate crosswalks and the bike lanes are narrow and unprotected next to 45 mph traffic. Bike lanes along roads with vehicle speeds in excess of 35 mph are not recommended for most cyclists, especially children. A crash between a vehicle and bicyclist or

pedestrian at over 40 mph has an 80% chance of being fatal. On Modoc Rd, there have been 9 crashes involving cars and bicyclists in the last 11 years. If we fail to build this path and take advantage of a funding source for signalized crosswalks, our youth and others will continue to be at greater risk on this stretch of road.

- Climate: In California, 40% of our emissions come from our transportation system. Automobile dependency is a major factor in our climate goal shortcomings. <u>Studies</u> find that swapping the car for walking, cycling and e-biking even just one day a week makes a significant impact on personal carbon emissions. Cyclists have 84% lower CO2 emissions from all daily travel than non-cyclists. Other cities that have added safe, separated bike paths have demonstrably reduced car trips. For instance, in the city of Davis, which extended separated bike paths from its UC campus to the rest of the city, fully 20% of commutes are made by bike.
- **Conservation:** Conservation and forestry experts approve of this plan, which provides a funding opportunity to extend native plant restoration and educational signage along the path, and to remove non-native trees, an explicit goal of the Modoc Preserve Conservation Easement. In addition to fire risk, non-native trees like eucalyptus and palms can use so much groundwater that they dry out wetlands, kill and crowd out other trees and plants, and require constant maintenance. Aging trees also pose dangers of falling or dropping limbs. Many of the trees removed would be eucalyptus, a non-native and highly flammable tree, and these would be replaced with oak trees, which are quick-growing, and both native and fire resistant. This is a better long-term choice given climate change and hotter, windier conditions.

We concur with the County that Alignment B is the preferred alternative, as it provides greater separation from the road, reduces the need for retaining walls and tree removals, especially palms, and would not negatively impact existing trails within the Modoc Preserve. We believe it would help meet the goals set when the Conservation Easement was created by providing equitable public access while promoting conservation values, and we hope that the Land Trust for Santa Barbara County and the La Cumbre Mutual Water Company will facilitate Alignment B. However, we think Alignment A is a valid alternative, and either option will provide many of the benefits specified above.

Hello I am writing regarding ITEM 43, which was the deferred project allocation for PS&E and RW funding (Item 96). This is the funding for Santa Barbara Modoc Preserve Phase B. This allocation marks the beginning of the Design and Right-of-Way phases.

Our organization "CAMP" still has a lawsuit pending, challenging the accuracy and completeness of their MND. This has not changed one bit. The county has pretty much decided not to try to resolve this matter. The county still has no agreement with the land owner La Cumbre Water Company nor the Santa Barbara Land Trust. There is the 1999 Deed of Conservation Easement . As you will recall the county had never discussed this matter with the Land Trust who oversees the property. You would think this easement would be required prior to any funding?

The county has a history in this project of not notifying all the parties involved. In my eyes they are dealing in bad faith.

Santa Barbara County has already received one extension. We are told that is all they are entitled to. So I'm really confused about what is going on now.

Please read the California Fish and Wildlife report. Since the county chose to ignore it. Item 13 now mentions sidewalks which is not included in their MND and was never mentioned previously nor was it mentioned at the BOS meeting on Nov. 1st.

I reviewed the plans for this project. I also live close by. I couldn't help to notice the high pressure gas pipeline that goes through a portion of this project. There are warning markers on over a 100 foot section. I took it upon myself to contact the CPUC. MR. MAHMOUD INTABLY (he goes by Steve) at the CPUC responded rather quickly. He emailed and called. (Mahmoud.intably@cpuc.ca.gov) (213-364-0027)

I explained the project, pictures, and I sent him the plans and information that I had. He was concerned, they didn't hear a word. I also had pictures of how phase 1 was progressing: the flooding, mudslides and all the heavy duty machinery. (These high pressure gas pipelines don't allow heavy machinery within 14 feet)

Next I got 3 calls from three Southern California Gas Company officials. They had no word regarding this project. Knew nothing about it. I sent them information as well. Matthew - <<u>MVardens@socalgas.com</u>>

It's interesting to note that Mahmoud called me several times. His last call he said they usually don't like to get involved in county affairs but since this is next to the train tracks and the 101 highway they will be taking a very active role in this. That statement really scared me at first but later I felt relieved. Finally common sense will prevail.

Since I got involved in this process I was so disappointed in how my local government was acting. I kept getting the feeling they were just "winging this". No plan, no discussions with the property owners, the Land Trust, so many people in the nearby neighborhood. The hp gas pipeline really upset me. Such a lack of responsibility, safety protocols.

I am completely opposed to this project. I believe it can be done just not the way they are trying to wing it.

I believe this project should be started completely over with a full EIR.

It is my understanding that March is the deadline for the project to receive an allocation of PS&E and Right of Way funding. This has been so mishandled.

Good afternoon Jose,

As I have mentioned previously in email correspondence (included at bottom of this email), I am a co-founder of CAMP (Community Association for the Modoc Preserve) which has nearly 6000 petition supporters in favor of our efforts to Save the Modoc Road Trees from being destroyed by a proposal to build a Multi-Use Path on private property in a protected nature preserve in Santa Barbara County...

It has been status quo on this project since your January 25th CTC meeting...Item 43...

We continue to have active litigation against Santa Barbara County Public Works and the SB County Board of Supervisors challenging the legality of the MND that was prepared by them and approved by them...we have a December 13, 2023 trial date before Judge Thomas Anderle in the Superior Court in the County of Santa Barbara.

The only thing that has changed is that there has been one more bike/vehicle collision (2/9/23) near the entrance to the Class I Obern Trail MUP caused by cyclists having to cross two lanes of traffic to make a left turn heading westbound on Modoc Road...as I have documented before, this was one of the primary reasons SB County Public Works gave in their 2018 ATP grant application. Another recent accident happened (11/9/22) in the exact location...both accidents were determined to be cyclist fault...but, the real fault is the westbound Class II lane that should be REPLACED, like SB County public works asked for...

It was never mentioned in the MND...nor were they mentioned in the Public Works presentation to the SB County BOS on November, 1...
