ACTION UPDATE:

- *The programmed amount of the Bob Jones Trail Extension Segment 2 project (PPNO 3060C) increased by \$1,620,000.*
- *Update Amendment Box: Adding new project Bob Jones Trail Extension Segment 2 (PPNO 3060C) changing “Existing” funds to “Change” funds to reflect the addition of the project.*

ISSUE:

Should the California Transportation Commission (Commission) approve the requested State Transportation Improvement Program (STIP) Amendment 24S-02?

RECOMMENDATION:

The California Department of Transportation (Department) and San Luis Obispo Council of Governments (SLOCOG) requests that the Commission approve the requested STIP Amendment 24S-02. This item was noticed at the Commission’s January 2025 meeting.

The Department and SLOCOG propose to amend the 2024 STIP to delete the Regional Improvement Program (RIP) funds from the Construction Capital (CON) phase of the US 101-Prado Road Overcrossing and Northbound Ramp Improvements project (PPNO 2831) and the Route 46/Union Road Intersection Improvements project (PPNO 2528). Reprogram these funds to the RIP Right of Way (R/W) Capital phase of the Route 46/Union Road Intersection Improvements project (PPNO 2528) and the remaining funds to the CON phase of

three new projects: Bob Jones Trail Extension Segment 2 project (PPNO 3060C), Shell Beach Road Shared Use Path Extension project (PPNO 3196), and the Morro Bay to Cayucos Multi-Use Trail Gap Closure Project (PPNO 3124) in San Luis Obispo County.

BACKGROUND:

The US 101-Prado Road Overcrossing and Northbound Ramp Improvements project (PPNO 2831) is currently programmed in the STIP with \$10,200,000 in RIP funds for the CON phase only. Due to a significant funding shortfall and a lack of local matching funds, SLOCOG has not been successful in securing a complete funding plan for this project. Although this remains a high priority project, SLOCOG is unable to proceed with the CON phase at this time due to a lack of required funding.

The Route 46/Union Road Intersection Improvements project (PPNO 2528) is currently programmed in the STIP with \$6,000,000 in RIP funds for the CON phase. However, due to significant delays and a funding shortfall, SLOCOG has not been successful in securing a complete funding plan for the CON phase. As the implementing agency is unable to proceed with the CON phase due to insufficient funding, and in order to utilize these STIP funds in a timely manner, SLOCOG is proposing to reprogram \$2,800,000 in RIP funds to the R/W Capital phase of the project.

In order to utilize the STIP funds in a timely manner, SLOCOG is proposing to reprogram \$10,200,000 in RIP funds from the US 101-Prado Road Overcrossing and Northbound Ramp Improvements project (PPNO 2831) and the remaining \$3,200,000 in RIP funds from the Route 46/Union Road Intersection Improvements project (PPNO 2528) to the CON phase of three new projects.

The Bob Jones Trail Extension Segment 2 project (PPNO 3060C) has already completed the environmental phase and is currently in the design phase. Once completed, this project will improve connectivity and provide enhanced multi-use transportation options for the region.

This project represents the second segment of the Bob Jones Trail Gap Closure project. The first segment (PPNO 3060) received \$18,248,000 in Active Transportation Program funding, which was approved by the Commission during its March 2021 meeting. However, unforeseen delays in acquiring necessary parcels through negotiations with property owners have hindered the project's progress. The alignment is being modified to utilize State-owned right-of-way to address this issue, allowing the project to advance.

Consequently, these realignment efforts have resulted in increased capital construction costs, which are being integrated into the updated project cost estimates as the design phase progresses toward completion.

The Shell Beach Road Shared Use Path Extension project (PPNO 3196) has completed the environmental phase and is currently in the design phase. Once completed, this project will improve bicycle and pedestrian mobility, reduce the potential for conflicts with vehicles on Shell Beach Road, and fill a gap in the regional active transportation network. Shell Beach Road experiences a high amount of cut-through traffic during the afternoon peak commute hours and during the summer months as travelers use the local parallel route to bypass traffic on United State Highway 101.

The Morro Bay to Cayucos Multi-Use Trail Gap Closure Project (PPNO 3124) has completed the environmental phase and is currently in the design phase. Once completed, it will provide a key connection to existing and future multi-modal routes serving community destinations and resources, schools, and recreational areas and provide important coastal access along the State Route 1 National Scenic Byway and the California Coastal Trail.

These funds shall be reprogrammed to the RIP R/W Capital phase of the Route 46/Union Road Intersection Improvements project (PPNO 2528) and the remaining funds to the CON phase of three new projects: Bob Jones Trail Extension Segment 2 project (PPNO 3060C), Shell Beach Road Shared Use Path Extension project (PPNO 3196), and the Morro Bay to Cayucos Multi-Use Trail Gap Closure Project (PPNO 3124), in San Luis Obispo County.
